# 6.1 RFT20DM01-SOR - PROVISION OF HOME SUPPORT SERVICES FOR THE FRAIL AGED AND YOUNGER PEOPLE WITH DISABILITIES WITHIN THE CITY OF SWAN

### **RECOMMENDATION**

It is recommended that the Tenders Review Committee resolve to:

- 1) Select Chanticleer Holdings Pty Ltd trading as TPG Aged Care Pty Ltd as the preferred Tenderer for the *Provision of Home support services for the frail aged and younger people with disabilities within the City of Swan / RFT20DM01-SOR* for the initial period of twelve months (12 months) from 1 May 2020 to 30 April 2021 for the schedule of rates as per the Tender's Offer with the anticipated value of the Contract being nine hundred and fifty two thousand, two hundred and two dollars and eighty two cents (952,202.82) excluding GST; and

- 1) Select Bellrock Cleaning Services Pty Ltd as the preferred Tenderer for the Cleaning Services to the City of Swan Facilities in Ellenbrook and Bullsbrook Place, and Swan Valley Place RFT19EV34-SOR for the initial period of thirty six (36) months from the 1 June 2020 until 31 May 2023 for the schedule of rates as per the Tenderer's Offer, with the anticipated value of the Contract being one million, four hundred and eighteen thousand, two hundred and sixty dollars and twenty seven cents (\$1,418,260.27) excluding GST;
