#### RECOMMENDATION

It is recommended that the Tenders Review Committee resolve to:

- Select <u>B&J Catalano Pty Ltd</u> as the preferred tenderer for the *Supply and delivery* of gravel – RFT21DM35-SOR for the initial period from the date of award to 30 June 2023 for the schedule of rates as per the tenderer's offer with the anticipated value of the contract being one million, six hundred and fifty eight thousand, nine hundred and fifty one dollars and twenty five cents (\$1,658,951.25) excluding GST
- 2) **Allow** the option to extend the contract by a further twenty-four (24) months
- 3) **Advise** all tenderers accordingly.

- 4) **Select** <u>Tyres4U Pty Ltd</u> as the preferred Tenderer for the *Provision of tyres, tyre fitting and maintenance services, and products – RFT21PH11* for the initial period of thirty-six months for the schedule of rates as per the Tender's Offer with the anticipated value of the Contract being one million, six hundred and fifty-five thousand, one hundred and ninety-nine dollars and eight-five cents (\$1,655,199.85) excluding GST
- 5) **Allow** the option to extend the Contract by a further twenty-four (24) months
