#### **RECOMMENDATION**

It is recommended that the Tenders Review Committee resolve to:

- 1) **Select** A.K.C. Pty Ltd T/A Baileys Fertilisers as the preferred tenderer for the Supply and delivery, and supply and application of turf care products RFT21KB39-SOR Separable Part A for the initial period from the date of award until 30 June 2023 for the schedule of rates as per the Tender's Offer with the anticipated value of the Contract being three hundred and thirty two thousand, five hundred dollars (\$332,500.00) excluding GST
- 2) **Select** A.K.C. Pty Ltd T/A Baileys Fertilisers as the preferred tenderer for the Supply and delivery, and supply and application of turf care products RFT21KB39-SOR Separable Part B for the initial period from the date of award until 30 June 2023 for the schedule of rates as per the Tender's Offer with the anticipated value of the Contract being seven hundred and eighty four thousand, one hundred and seventeen dollars and twenty cents (\$784,117.20) excluding GST
- 3) **Allow** the option to extend the contract by a further twenty four (24) months
- 4) Advise all tenderers accordingly.
