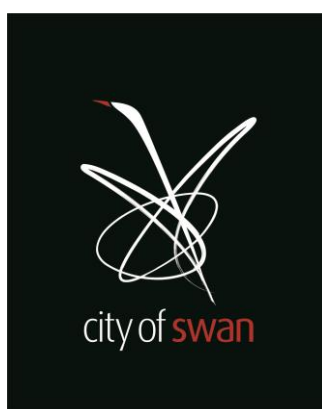


## CITY OF SWAN RECOMMENDATION


It is recommended that the City resolve to:

- 1) **Select** OPRA Australia Pty Ltd T/A OPRA Psychology Group as the preferred tenderer for the *Provision of Leadership and Employee Development Program – Separable Part A – RFT21CH71-SOR* for the initial period from the date of award until 30 June 2023 for the schedule of rates as per the tenderer's offer with the anticipated value of the contract being fifty eight thousand, seven hundred and sixty dollars (\$58,760.00) excluding GST
- 2) **Select** Perquiro Consulting Pty Ltd As Trustee For The Perquiro Consulting Trust as the preferred tenderer for the *Provision of Leadership and Employee Development Program – Separable Part B – RFT21CH71-SOR* for the initial period from the date of award until 30 June 2023 for the schedule of rates as per the tenderer's offer with the anticipated value of the contract being nineteen thousand and six hundred dollars (\$19,600) excluding GST
- 3) **Select** Cognicent Pty Ltd as the preferred tenderer for the *Provision of Leadership and Employee Development Program – Separable Part C – RFT21CH71-SOR* for the initial period from the date of award until 30 June 2023 for the schedule of rates as per the tenderer's offer with the anticipated value of the contract being thirty two thousand and six hundred dollars,(\$32,600) excluding GST
- 4) **Select** Integral Development Associates as the preferred tenderer for the *Provision of Leadership and Employee Development Program – Separable Part D – RFT21CH71-SOR* for the initial period from the date of award until 30 June 2023 for the schedule of rates as per the tenderer's offer with the anticipated value of the contract being thirty nine thousand, six hundred and thirty dollars (\$39,630) excluding GST
- 5) **Select** OPRA Australia Pty Ltd T/A OPRA Psychology Group as the preferred tenderer for the *Provision of Leadership and Employee Development Program – Separable Part E – RFT21CH71-SOR* for the initial period from the date of award until 30 June 2023 for the schedule of rates as per the tenderer's offer with the anticipated value of the contract being fifty eight thousand, seven hundred and sixty dollars (\$58,760) excluding GST

- 7) **Allow** the option to extend the contract by a further 12 months
- 8) **Advise** all tenderers accordingly.
