The proposal must encompass the following

- The location of the structure
- Location of the nearest streetlight or other source that will illuminate the structure after sunset

The structure may not be placed on, encroach or impede access to:

- Roads or intersections
- Footpaths
- Neighbouring crossovers
- Public Access Ways
- Parking bays

The structure must maintain a 1.5m minimum distance from:

- Roads or Kerb
- Trees
- Structural Elements including power poles, signs, fire hydrants, public service pits, bus stops

Other things to be shown in the drawing

- The structure's proximity to intersections

6. Conditions of Approval

Conditions

1. The applicant is to take all safety and protective measures and do all things necessary to prevent accidents or injury to persons, or damage to private property or infrastructure. Reflective tape must be placed on the corners of structures to improve visibility.
2. Nothing shall extend outside the proposed area referred to in this application. All structures and any extraneous material must be removed by the expiry date and the road and/or footpath left clean and tidy. The structure must not be on / overhang / impede access to a footpath, and not be located on the road (or within 1.5m of the road).
3. Traffic safety must not be compromised at any time.
4. The applicant shall accept liability for any loss or damage that occurs to the road pavement, footpath or any City infrastructure that occurs as a result of the placement or removal of the structure.
5. No temporary structure may be placed so as to obstruct use of a footpath or roadway. If the City exercises discretion and allows a structure to be placed on or across a footpath the applicant must first create and maintain all adequate measures to ensure safe passage is available for pedestrians
6. The applicant must ensure that placed things and protective structures are sufficiently illuminated from sunset to sunrise.
7. This approval may be revoked at any time by the City of Swan if the approval holder fails to comply with a condition of the approval, a direction of the City of Swan or any other reason. Any structure shall be permanently removed within 24 hours of the approval being revoked
8. Nothing in this approval constitutes a variation to any existing parking requirements.
9. The vision of motorists is not to be obstructed.
10. Structures must be a minimum of 1.5 metres from the base of any tree located on the verge. Nothing in this approval authorises the removal of, or damage to a street tree.
11. The applicant shall indemnify the City of Swan against any claim, loss or expenses incurred by the City as a result of any breach of any approval given by the City.
12. This approval is issued under the Local Government (Uniform Local Provisions) Regulations 1996. Failing to comply with conditions in any approval attracts fines of \$5,000 and daily penalties of \$500 for each day which the offence continues.

7. Declaration

I/we the undersigned acknowledge that I/we have understood the conditions that apply. I /we the Applicant confirm that a copy of this application, including the conditions, has been provided to the company providing the temporary structure. I / we have notified all neighbouring properties of our application to place a temporary structure, including the location of structure and duration of its placement.
